<sup>2</sup> In the case of CRPD OPT - Article 8, the State has the option of making a declaration in accordance with the terms of the Optional Protocol. Article 8 allows a State party to declare that it does not recognize the competence of the Committee on the Rights of Persons with Disabilities to conduct confidential inquiries where the Committee has received reliable information indicating grave or systematic violations of the rights set forth in the Convention (under Articles 6 and 7 of the Convention).

<sup>3</sup> “s” means that the State party is only a signatory.

- <sup>4</sup> Formerly Libyan Arab Jamahiriya. In August 2011, the Permanent Mission of Libya notified the Secretary-General of a Declaration by the National Transitional Council of 3 August changing the official name of the Libyan Arab Jamahiriya to "Libya" and changing Libya's national flag.
- <sup>5</sup> The Republic of South Sudan formally seceded from Sudan on 9 July 2011, as a result of an internally monitored referendum held in January 2011, and was admitted as a U.N. member state by the General Assembly on 14 July 2011.
