¹ On 3 October 1990 the Federal Republic of Germany notified the Secretary-General that through the accession of the German Democratic Republic to the Federal Republic of Germany, with effect from 3 October 1990, the two German states had united to form one sovereign state, to act in the United Nations under the designation “Germany”.

⁴ In its concluding observations adopted on 21 March 2001, the Committee on the Elimination of Racial Discrimination requested that the sixteenth and seventeenth periodic reports be submitted jointly with the eighteenth periodic report, due on 15 June 2004.

⁵ The sixteenth, seventeenth and eighteenth periodic reports were submitted together as one document.

⁶ In its concluding observations adopted on 13 August 2008, the Committee on the Elimination of Racial Discrimination requested that additional information be submitted within one year, and recommended that the state party submit a combined nineteenth, twentieth, twenty-first and twenty-second periodic report in a single document, due on 15 June 2012.
