Many follow-up replies received may be considered satisfactory, in that they display the willingness of the State party to implement the Committee's recommendations or to offer the complainant an appropriate remedy. Other replies cannot be considered satisfactory because they either do not address the Committee's Views at all or only relate to certain aspects of them. Some replies simply note that the victim has filed a claim for compensation outside statutory deadlines and that no compensation can therefore be paid. Still other replies indicate that there is no legal obligation on the State party to provide a remedy, but that a remedy will be afforded to the complainant on an *ex gratia* basis.

The remaining follow-up replies challenge the Committee's Views and findings on factual or legal grounds, constitute much-belated submissions on the merits of the complaint, promise an investigation of the matter considered by the Committee or indicate that the State party will not, for one reason or another, give effect to the Committee's Views.

New information had been received very recently regarding the case pertaining to Serbia, which had confirmed that a compensation agreement had been reached between the Serbian Ministry of Justice and the author, in accordance with which the latter had received 800,000 dinars. No comments had been received concerning the Committee's recommendation to quash the author's conviction. The Committee might wish to contact the State party on that question, and the dialogue could therefore be considered ongoing.

United Nations Development Programme that the author had signed an agreement with the Ministry of Justice according to which he will receive 800,000 dinars (approximately 10,000 euros) for reparations

and restitution.

On 25 July 2008, the author informed the Committee that he had

accepted compensation of 800,000 dinars for the violation of his rights under the Covenant.

Committee's Decision

The Committee welcomes the award of compensation, which the author accepts as a remedy for the violation of his rights under the Covenant, and regards the State party's response as satisfactory.
