<sup>1</sup> Czechoslovakia had ratified CERD on 29 December 1966, CCPR on 23 December 1975, CCPR OP 1 on 12 March 1991, CESC on 23 December 1975, CEDAW on 16 February 1982, CAT on 7 July 1988, CRC on 7 January 1991, and subsequently Czechoslovakia dissolved into the states of Czech Republic and Slovakia. In a letter dated 16 February 1993, the Government of the Czech Republic, as a successor state, notified the Secretary-General that it considered itself bound, as of 1 January 1993, i.e., the date of dissolution of the Czech and Slovak Federal Republic, by multilateral international treaties to which the Czech and Slovak Federal Republic was a party on that date.

<sup>2</sup> The Human Rights Committee set the date for the submission of the second periodic report at 4 February 1983.

<sup>3</sup> In its concluding observations adopted on 30 July 1997, the Human Rights Committee set the date for the submission of the second periodic report at 31 December 2001.

<sup>4</sup> In its concluding observations adopted in July 2003, the Human Rights Committee requested that additional information be submitted within one year, and set the date for the submission of the third periodic report at 1 August 2007.

<sup>5</sup> At its eighty-fourth session in July 2005, the Committee decided to take no further action.

<sup>6</sup> In its concluding observations adopted on 28 March 2011, the Human Rights Committee requested that additional information be submitted within one year and that the next periodic report be submitted by 1 April 2015.
