Resumed organizational session for 1994

ELECTIONS, NOMINATIONS AND CONFIRMATIONS

Election of nine members of the Committee on Economic,
Social and Cultural Rights

Note by the Secretary-General

1. By its resolution 1985/17, the Economic and Social Council decided to establish a Committee on Economic, Social and Cultural Rights to undertake functions relating to the implementation of the International Covenant on Economic, Social and Cultural Rights and to assist the Council in fulfilling its responsibilities under the Covenant.
2. In accordance with that resolution, the Council, at its first regular session of 1990, elected by secret ballot, from a list of persons nominated by States parties to the Covenant, nine experts as members of the Committee on Economic, Social and Cultural Rights, for a four-year term beginning on 1 January 1991 and ending on 31 December 1994 (decision 1990/212). The current membership of the Committee is given in annex I below.
3. At its present session, the Council is to elect nine members of the Committee for a four-year term, beginning on 1 January 1995. The terms of the following members expire on 31 December 1994: Philip ALSTON (Australia), Abdel Halim BADAWI (Egypt), Virginia BONOAN-DANDAN (Philippines), Luvsandanzangiin IDER (Mongolia), Valery KUZNETSOV (Russian Federation), Jaime MARCHAN ROMERO (Ecuador), Alexandre MUTERAHEJURU (Rwanda), Bruno SIMMA (Germany), Javier WIMER ZAMBRANO (Mexico).
4. In a note verbale dated 22 December 1993, the Secretary-General invited the States parties to the International Covenant on Economic, Social and Cultural Rights to submit their nominations for membership in the Committee. The names of the persons nominated as at 18 March 1994 are set out below, together with the States parties that nominated them:
