## **Provisional agenda and annotations**

### **Note by the Secretary-General**

1. The forty-sixth session of the Committee against Torture will be held at the United Nations Office at Geneva (Palais Wilson) from 9 May to 3 June 2011. The first meeting of the session will be convened on Monday, 9 May, at 10.00 a.m.
