## Provisional agenda and annotations\*

### Note by the Secretary-General

1. The forty-ninth session of the Committee against Torture will be held at the United Nations Office at Geneva (Palais Wilson) from 29 October to 23 November 2012. The first meeting of the session will be convened on Monday, 29 October, at 10 a.m.
