# ELECTION, IN ACCORDANCE WITH ARTICLES 28 TO 32 OF THE INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS, OF NINE MEMBERS OF THE HUMAN RIGHTS COMMITTEE TO REPLACE THOSE WHOSE TERMS ARE DUE TO EXPIRE ON 31 DECEMBER 2004

# Note by the Secretary-General

1. In conformity with articles 30, paragraph 4, and 32 of the International Covenant on Civil and Political Rights, the Twenty-third Meeting of States Parties to the Covenant will be convened by the Secretary-General at United Nations Headquarters on Thursday, 9 September 2004, for the purpose of electing nine members of the Human Rights Committee from a list of persons nominated by States parties (annex I) to replace those whose terms are due to expire on 31 December 2004 (annex II). The names of the other nine members who will continue to serve on the Committee until 31 December 2006 appear in annex III.

2. In accordance with article 30, paragraph 2, and article 34 of the Covenant, the Secretary-General, in a note verbale dated 17 February 2004, invited the States parties to submit, in conformity with article 29 of the Covenant, their nominations for the election of nine members of the Committee within three months, i.e. by 17 May 2004.

3. Annex IV contains the curricula vitae of the persons whose nominations had been received by the Secretariat by the end of the day on 17 May 2004.
