- 1978-1984: Member of the Board of Directors of the Savings Bank of Rwanda (a semi-public institution providing <u>inter alia</u> assistance to small savers)
- 1981 to date: Member of the Governing Council of the National Population Office (public body responsible for the country's demographic policy)
- 1984 to date: Chairman of the Board of Directors of the Centre for Research and Training in Co-operatives (a private non-profit-making centre)
- 1984 to date: Member of the National Commission for UNESCO.
- <u>Publications</u>: 1. Author of the "Monograph on the law relating to women and on the status of women in Rwanda", a study written as part of research on various topics being conducted by the African Training and Research Centre for Women (an institution of the United Nations Economic Commission for Africa (ECA)).
  - Collaborated in the evaluation of the United Nations Decade for Women in Rwanda, made for the United Nations Development Programme (UNDP) (study completed in May 1984).
  - Collaborated in the study "Analysis of the situation of Rwandese children" (for UNICEF and the Rwandese Planning Ministry, study published in February 1986).
