ELECTION OF NINE MEMBERS OF THE COMMITTEE ON THE ELIMINATION OF RACIAL DISCRIMINATION TO REPLACE THOSE WHOSE TERMS WILL EXPIRE ON 19 JANUARY 2004, IN ACCORDANCE WITH THE PROVISIONS OF ARTICLE 8

OF THE CONVENTION

#### Note by the Secretary-General

- 1. In pursuance of article 8, paragraph 4, of the International Convention on the Elimination of All Forms of Racial Discrimination, the Twentieth Meeting of States Parties to the Convention will be convened by the Secretary-General at United Nations Headquarters on 14 January 2004 to elect nine members of the Committee on the Elimination of Racial Discrimination to replace those whose terms are due to expire on 19 January 2004 (see annex I). The names of the other nine members who will continue to serve on the Committee until 19 January 2006 appear in annex II.
- 2. In accordance with article 8, paragraph 3, of the Convention, the Secretary-General, in a note verbale dated 25 July 2003 invited the States parties to submit their nominations for the election of nine members of the Committee within two months. Seventeen nominations had been received by 25 September 2003. An eighteenth nomination, that of Burundi, was submitted on 3 October 2003, and a nineteenth nomination, that of Mali, was received on 21 October 2003. Nominations and biographical data of persons that may be received by the secretariat after 24 October 2003 will be brought to the attention of the States parties in addenda to this note. Listed below in alphabetical order are the nominees, with the States parties that have proposed them indicated in parenthesis:

Assistant Attorney-General of the United States for Civil Rights and the Chief of the Civil Rights Division of the United States Department of Justice. As such, Mr. Boyd was the nation's chief civil rights law enforcement officer.

In that role, he was responsible for overseeing and

directing 375 attorneys in the Civil Rights Division, which is the primary agency within the Federal Government responsible for enforcing the nation's criminal and civil laws prohibiting discrimination on the basis of race, colour, religion, or national origin. Mr. Boyd also previously served as an Assistant United States Attorney in Boston, Massachusetts. In that role, he investigated and prosecuted homicide, narcotics and firearms

trafficking, and bombing cases, and cases involving gang violence

Educational background: BA degree in political science from Haverford College

in 1979; a JD degree from the Harvard Law School 1984; and an honorary Doctor of Laws degree from Suffolk University in 2001. He has taught numerous continuing legal education and trial training courses, including the

Trial Advocacy Workshop at Harvard.

Mr. Boyd also frequently speaks about human and civil

rights, terrorism and criminal law issues.

In August 2001, Mr. Boyd presented the United States case before the Committee on the Elimination of Racial Discrimination in Geneva. In June 2003, he represented the United States before the United Nations Ad Hoc Committee on the Protection and Promotion of the Rights and Dignity of Persons with Disabilities. From 2001 to 2003, Mr. Boyd was a member of the United States delegation to the United States-China Human Rights Dialogue, and in September 2003 served on the United States delegation to the Organization for Security and Cooperation in Europe Conference on Racism, Discrimination, and Xenophobia in Vienna. Mr. Boyd also is a former co-Chair of the Brown v. Bd. of Education Presidential Commission, which was established to commemorate the fiftieth anniversary of the seminal 1954 Supreme Court decision outlawing racial segregation in America's public schools.

As Assistant Attorney-General, Mr. Boyd and his senior staff drafted, published, and assisted in the implementation of the Government's Guidance to Federal Law Enforcement Regarding the Use of Race and Ethnicity. President George W. Bush directed that this guidance to federal law enforcement, which prohibits racial profiling in law enforcement operations, be implemented as official, federal executive policy.
