Elections, nominations, confirmations and appointments

Election of nine members of the Committee on Economic, Social and Cultural Rights

Note by the Secretary-General

1. By its resolution 1985/17, the Economic and Social Council decided to establish a Committee on Economic, Social and Cultural Rights to undertake functions relating to the implementation of the International Covenant on Economic, Social and Cultural Rights and to assist the Council in fulfilling its responsibilities under the Covenant.
2. In accordance with that resolution, the Council, on 3 May 2000, elected from a list of persons nominated by States parties to the Covenant, nine experts as members of the Committee on Economic, Social and Cultural Rights, for a four-year term beginning on 1 January 2001 and ending on 31 December 2004. The current membership of the Committee is given in annex I to the present note.
3. In 2004, the Council is to elect nine members of the Committee for a four-year term, beginning on 1 January 2005. The terms of the following members expire on 31 December 2004: Rocío Barahona Riera (Costa Rica), Dumitru Ceausu (Romania), Abdessatar Grissa (Tunisia), Giorgio Malinverni (Switzerland), Sergei N. Martynov (Belarus), Ariranga Govindasamy Pillay (Mauritius), Kenneth Osborne Rattray (Jamaica), Waleed M. Sa'di (Jordan) and Philippe Texier (France).
4. In a note verbale dated 29 November 2003, the Secretary-General invited States parties to the Covenant to submit their nominations for membership in the Committee. The names of the persons nominated as at 1 March 2004 are set out below, together with the States parties that nominated them.

However, the plan of action of the Committee of the Eradication of the Abduction of Women and Children for 2004 is to find and document the remaining abductees within this year.
