# **Election of nine members of the Committee on Economic, Social and Cultural Rights**

#### Note by the Secretary-General

- 1. By its resolution 1985/17, the Economic and Social Council decided to establish a Committee on Economic, Social and Cultural Rights to undertake functions relating to the implementation of the International Covenant on Economic, Social and Cultural Rights and to assist the Council in fulfilling its responsibilities under the Covenant. The members are elected from a list of persons nominated by States parties to the Covenant.
- 2. In 2010, the Council is to elect nine members of the Committee for a four-year term beginning on 1 January 2011 to fill vacancies that will occur upon the expiration, on 31 December 2010, of the terms of the following members: Clément Atangana (Cameroon), Aslan Abashidze (Russian Federation), Virginia Bonoan-Dandan (Philippines), Maria Virginia Brás Gomes (Portugal), Chandrashekhar Dasgupta (India), Azzouz Kerdoun (Algeria), Jaime Marchán Romero (Ecuador), Eibe Riedel (Germany) and Alvaro Tirado Mejía (Colombia).
- 3. In a note verbale dated 26 October 2009, the Secretary-General invited States parties to the Covenant to submit their nominations for membership in the Committee within three months. The names of the persons nominated are set out below, together with the States parties that nominated them. Biographical information on the candidates will be issued in document E/2010/9/Add.11.
