### Election to fill a vacancy in the Committee on Economic, Social and Cultural Rights

#### Note by the Secretary-General

1. In a letter dated 27 July 2010, **Zhan** Daode (China) notified the Secretary-General, through the Chair of the Committee on Economic, Social and Cultural Rights, of his decision to resign as a member of the Committee with immediate effect. Mr. Zhan's term of office was due to expire on 31 December 2012. The present members of the Committee, are listed in annex III to the report of the Economic and Social Council for 2010 (A/65/3).

2. In a note verbale dated 11 August 2010, the Secretary-General informed the States parties to the International Covenant on Economic, Social and Cultural Rights from the regional group of Asian States of Mr. Zhan's resignation. In accordance with paragraphs (b) and (c) of Economic and Social Council resolution 1985/17 of 28 May 1985 and rule 12 of the provisional rules of procedure of the Committee on Economic, Social and Cultural Rights, the Secretary-General invited the Governments concerned to submit, by 11 October, their nominations for membership in the Committee to fill the vacancy therein for the remainder of Mr. Zhan's term of office.

3. As at 11 October 2010, the Secretary-General had received the nomination of **Cong Jun**, submitted by China. Biographical information on Ms. Cong is presented below.
