GENERAL MEASURES OF IMPLEMENTATION (Articles 4, 42, and 44, paragraph 6 of the Convention)

- 1. Please indicate whether the Convention on the Rights of the Child can be invoked in domestic courts and, if so, provide some examples of its use in this regard. With reference to paragraph 8 of the report, please identify the inconsistencies between the Convention and the Constitution and other domestic law and highlight the measures taken to address these inconsistencies. Please also provide information on any additional measures taken and/or envisaged to bring legislation and practice into line with the principles and provisions of the Convention.
- 2. Please provide additional information regarding the mandate and activities of the Committee for the Protection of Human Rights and for Ethnic Relations as well as the Office of the Public Human Rights Defender or Ombudsman and indicate the extent to which these two bodies cooperate or interact with each other. Additionally, please indicate whether the executive committee or the office of the ombudsman is specifically mandated to handle cases in relation to the violation of children's rights. If so, please describe the procedure and indicate the number and nature of such cases dealt with so far.

BASIC HEALTH AND WELFARE

Additionally, please also describe how this programme relates to the "Integrated Management of Childhood Illness" strategy. Please also provide additional information on the situation of tuberculosis (TB) among children and indicate whether there is an intention to extend the coverage of the "Directly Observed Treatment Strategies" (DOTS) for children with TB and introduce measures to ensure its sustainability.
- 11. Please provide additional information concerning the implementation of article 23 of the Convention. In particular, please provide details about the prevalence of childhood disabilities as well as the programmes established to assist these children and their families. In this context,

please also indicate what measures have been taken to facilitate the training of professionals working with children with disabilities. Please describe the prevailing social attitude toward children with disabilities and indicate what measures have been taken to raise public awareness about their special needs. Additionally, please describe the measures taken to ensure the social integration of children with disabilities and to further guarantee the rights of those children with disabilities living in institutions.

- 12. Please provide additional information on the situation of adolescent health, including reproductive health, teenage pregnancy, HIV/AIDS and STDs, violence and suicide, and outline the policies and programmes implemented in this regard. Please describe the role of adolescents in identifying health priorities for their age group and in planning, implementing and monitoring these interventions.
- 13. With reference to information provided in paragraphs 237-239 of the report, concerning the deterioration of the social services system in Georgia, please provide information on the measures taken and/or foreseen to improve the system and (re)establish adequate programmes for the economically disadvantaged in the country.

EDUCATION, LEISURE AND CULTURAL ACTIVITIES (Articles. 28, 29 and 31 of the Convention)

- 14. Please provide additional information, including statistical data, on the student teacher ratio; the enrolment and dropout rates; and the availability of classrooms, qualified teachers, relevant learning material, and other resources. With regard to information provided in paragraph 257 of the report, please indicate whether measures have been taken or are envisaged to ensure the realization of the participatory rights of children within the school system, including their concrete involvement in the school teacher councils and disciplinary proceedings. Further, with respect to information provided in paragraph 189 of the report, concerning the results of the survey on, inter alia, the use of corporal punishment in schools, please indicate whether a complaints procedure has been established within the school system for students whose rights have been violated. Additionally, please indicate whether there is a concern with respect to violence among and against students in school.

Please provide information on landmines in Georgia and indicate what measures have been taken to locate and clear landmines, especially in the western regions of the country, along the border zones. Additionally, please indicate the number of child victims of landmines and outline the programmes established to facilitate their care and rehabilitation. Further, please provide information on the programmes established to raise awareness and to prevent future mishaps involving children and landmines.
- 19. In light of articles 37, 40 and 39 of the Convention, concerning the rights of children alleged as, accused of, or recognized as having infringed the penal law, please provide additional information on:
- (a) The use of arrest, detention or imprisonment of a child as a measure of last resort and for the shortest period of time;
- (b) The measures taken to introduce alternative forms of punishment (other than imprisonment) for children in conflict with the law;
- (c) The possibility to have prompt access to legal or other appropriate assistance, as well as for challenging the legality of the deprivation of liberty before a court or other competent, independent and impartial authority, and of having a prompt decision thereon;
- (d) The measures taken to ensure that legal proceedings are conducted in a language which is understood by the child or that interpreters are provided by the State to facilitate the process in this regard;
- (e) The extent to which the complaint procedure recently established under the procurator's office is known and utilized by children in detention to address issues of ill-treatment and other violations of their rights;
- (f) Services for the recovery and rehabilitation of children alleged as, accused of or recognized as having infringed the penal law and their effectiveness;
- (g) TWhe measures taken and/or foreseen to ensure that the juvenile justice system is equally accessible in all regions of the State party;

- (h) The treatment of girls in conflict with the law (especially detention facilities for girls).
