IMPLEMENTATION OF THE CONVENTION ON THE RIGHTS OF THE CHILD

<u>List of issues to be taken up in connection with the consideration</u> of the initial report of **Saint Lucia (CRC/28/Add.23)**

Part I

Under this section the State party is requested to submit in <u>written form</u> additional and updated information, if possible, <u>before 6 April 2005</u>:

A. Data and statistics, if available

- 1. Please provide disaggregated statistical data (by sex, age groups, migrant groups, including those without proper documentation, urban and remote areas) covering the years 2001, 2002, 2003 and 2004 on the number and proportion of children under 18 living in the State party.
- 2. In light of article 4 of the Convention, please provide additional data disaggregated for the years 2001, 2002, 2003 and 2004, on budget allocations and trends (in absolute figures and percentages of the national and local budgets and/or GDP) allocated to the implementation of the Convention, evaluating also the priorities for budgetary expenditures given to the following:
 - a) education (different types of education, i.e. pre-primary, primary and secondary education)
 - b) health care (different types of health services, i.e. primary health care, vaccination programmes, adolescent health care and other health care services for children, including social insurance);
 - c) support programmes for families;
 - d) children with disabilities:

- e) the protection of children who are in need of alternative care including the support of care institutions;
- f) child care services, including day care centers;
- g) programmes and activities for the prevention and protection from child abuse, child sexual exploitation and child labour; and
- h) juvenile justice
- 3. With reference to children deprived of a family environment and separated from parents, please provide disaggregated data (by gender, age group, immigrant groups, urban and remote areas) for the years 2001, 2002, 2003, 2004 on the number of children.
 - a) separated from their parents;
 - b) placed in institutions;
 - c) placed with foster families; and
 - d) adopted domestically or though inter-country adoption.
- 4. Please provide disaggregated statistical data (by sex, age, urban or remote areas) covering the period 2001-2004 on the:
 - a) number and percentage of children with disabilities;
 - b) number of children with disabilities either taken care of in the family or living in institutions;
 - c) number of children with disabilities being enrolled in regular education, how many benefit from the special education system and how many are not in school; and
 - d) facilities and services available for children with disabilities.
- 5. With reference to child abuse, (including sexual abuse for a. and b.), please provide disaggregated data (by age, gender and types of violations reported) over the period 2001–2004 on the:
 - a) number of reported cases of child abuse;
 - b) number and percentage of reports which have resulted in either a court decision or other types of follow-up; and
 - c) programmes and activities to sensitize parents concerning child abuse, including corporal punishment.
- 6. Please provide disaggregated statistical data (by gender, age, migrant groups, urban or remote areas) covering the years 2001, 2002, 2003 and 2004 in percentage of the relevant age group on the:
 - a) enrolment in percentage of children in primary and secondary schools;
 - b) percentage of children completing primary and secondary education:
 - c) number and percentage of drop-outs and repetition rate;
 - d) ratio teacher per children and number of children per class; and
 - e) number of children who attend pre-school education.

- a. 7. Please provide updated disaggregated statistical data (by gender, urban and remote areas) on infant and child mortality, malnutrition and obesity, adolescent health, including early pregnancy and sexually transmitted infections (STIs); children affected or infected by HIV/AIDS; drug, alcohol abuse and tobacco and other substance abuse for the years 2001, 2002, 2003 and 2004. Also, please provide numbers of health professionals working in the health care services for children.
- 8. Please provide the following statistical data (disaggregated by gender, age, type of crime) for the last three years (2001-2004):
 - a) number of persons below 18 who allegedly committed a crime reported to the police;
 - b) number of persons below 18 who were sentenced and the nature of sanctions (community service; detention; other types of sanctions);
 - c) the number of persons below18 detained and imprisoned, the location of their detention or imprisonment (e.g. police station, jail or other place) and the lengths of their detention or imprisonment, including pre-trial detention;
 - d) number of persons below 18 detained in adult facilities;
 - e) reported cases of abuse and maltreatment of persons below 18 occurred during their arrest and detention.
- 9. With reference to special protection measures, please provide statistical data (including by gender, age, urban and remote areas) per year between 2001 and 2004 on the number of children:
 - a) involved in sexual exploitation, including pornography, sale and trafficking and the number of those children who were provided access with rehabilitation treatments;
 - b) involved in substance abuse and the number of those children who received rehabilitation treatments;
 - c) involved in child labour (formal or informal sectors).

B. General Measures of Implementation

- 1. Please provide further information on the efforts undertaken by the State party to harmonize domestic law with the provisions and principles of the Convention. Please specify the legal status of the Convention in the domestic legal order and explain whether the Convention can be directly invoked in Courts (if so, please provide examples).
- 2. Please provide more information on mechanisms to lead and coordinate policies and programmes on children's rights.

- 3. Please provide detailed information on the development and implementation of a National Plan of Action.
- 4. Please indicate if there is any independent monitoring mechanism which is, inter alia, mandated and resourced to receive and handle individual complaints from children and if so please provide information about the mandate, human and financial resources and number of cases dealt with
- 5. Please provide information on the system of data collection and whether it covers all persons below 18 and all areas referred to in the Convention.
- 6. Please provide additional information on how governmental institutions cooperate with non-governmental organizations, especially concerning the participation of representatives of civil society in the design and implementation of policies and programmes for children.
- 7. Please provide information on the dissemination of the Convention on the Rights of the Child in the State party. Please also specify whether measures have been taken to sensitize and/or train professional groups working for/with children on the rights of the child.
- 8. Please indicate the issues affecting children that the State party considers to be priorities requiring the most urgent attention with regard to the implementation of the Convention

Part II

Please provide the Committee with copies of the text of the Convention on the Rights of the Child in other languages or dialects of the State party, when available. If possible, please submit these texts in electronic form.

Part III

Under this section, States parties are invited, whenever appropriate, to briefly (3 pages maximum) up-date the information provided in their report with regard to:

- new bills or enacted legislation
- new institutions
- newly implemented policies
- newly implemented programmes and projects

Part IV

The following is a preliminary list (that does not contain issues already covered in Part I) of major issues that the Committee intends to take up during the dialogue with the State party. They do not require written answers. This list is not exhaustive as other issues might be raised in the course of the dialogue.

- 1. Definition of the child.
- 2. Non-discrimination.
- 3. Right to express views freely and have them given due weight in decisions which affect children, including in schools and in the family.
- 4. Birth registration.
- 5. Child poverty and inequalities.
- 6. Violence against children, in particular corporal punishment, including in the family and in schools. Measures taken to address domestic violence, sexual abuse and access for victims to recovery and reintegration assistance.
- 7. Quality of and accessibility to health services.
- 8. Measures taken to address adolescent health concerns, including reproductive health, mental health, HIV/AIDS and early pregnancy.
- 9. Access of children with disabilities to education and professional trainings. Measures taken to ensure the non-discrimination of children with disabilities.
- 10. Substance abuse and programmes of care and rehabilitation.
- 11. Economic exploitation, including child labour.
- 12. Sexual exploitation.
- 13. Juvenile justice.
