The probable increase in the number of deaths raises the issue of orphans and their family insertion, and needless to mention is the dramatic situation of children born HIV-positive due to vertical transmission and whose number will probably increase in the near future.....transmission from mother to child represents 7% of identified cases." \*\*\*

The national legislation is compatibility with the provision and principle of the Convention on the Rights of the Child with the approval of

the new Constitution in 1992. The Constitution is the fundamental law of Cape Verde were all the Rights of the Child are included.

Cape Verde is a democratic country, there for the rights of the Child is an important issue.

In addition to the Constitution there has been made other laws to protect the child.

# Laws that protect the Child

- 1. The Constitution (art. 89°, 73° and 75
- 2. Minor's code- Decreto-lei nº 89/82 of 25 Setember
  - 3. Law nº 27/V/97-Restricts alcohol to minor's
- 4. Law n° 13/97-No one under 16 can be inside, bars and discos
  - 5. Law n° 81/V/98-About sexual abuse and child pornography
- 6. Law n° 29/V/91-Ratification of the Convention on the Rights of the Child
  - 7. Law 10/97-There is no fine for late birth registration
- 2. Please provide details of progress made in implementing the State party's National Plan of Action for childhood and adolescence, and its impact on the Convention's implementation.

After the ratification of the Convention on the Rights of the Child several measures were adopted to implement the Convention.

The approval of the Constitution in 1992 was the most important measure. The approval and ratification of international agreements in Civil and Political Rights, Economic Rights and related issues were other measure done by the country.

Cape Verde belongs to the "African Charter on the rights and welfare of the child".

The approval of new legislation with significant changes in the Family Code, Civil Code and Minor's Code.

At the institution level, the Capeverdian Minor's (ICM) a public institution dedicated to protecting and promoting children's rights created in 1982.

In 1995, The Government approved the "National Declaration on Social policy for children and adolescence". This document shows the problems of children in Cape Verde, gives advice and strategies to achieve the Rights of the Child.

Cape Verde has adopted all recommendations from important conferences such as:

- Fundraising for Children's issues
- Adopted the National Plan for Children
- Ratified the "African Charter on the rights and welfare of the child".

After the "World Summit for Children", in 1995, was held the National Conference on Social Policy for children and adolescence were the "National Declaration on Social policy for children and adolescence" was singed.

This declaration made impact on Capeverdian society. It raise the preoccupation about children's problems in the country.

# The government created the National Committee of Human Rights.

Associação de Apoio ao Deficente- NGOs that support disabilities OMCV- Organização das Mulheres de Cabo Verde-Organisation to protect and promote Women's Rights.
