

# Reply to the issues raised in paragraph 1 of the list of issues (CRC/C/OPSC/SWE/Q/1)

## Question 1(a)

1. The total number of reported offences regarding the sale of children, child prostitution and child pornography is shown below: (Source: National Council for Crime Prevention, Brå)

2. Brå is responsible for the Swedish official crime statistics. Brå is currently not able to follow a reported crime through the legal chain, among other things due to differences between crime statistics and convictions statistics. Development work is however being done, aiming to introduce a structured electronic flow of information between the different judicial authorities. Therefore, in the future, it will probably be possible to follow a case through the legal chain.

5. Since reporting of convictions decisions is strictly based on the legal structure, it is currently not possible to separate Internet-based child pornography offences from other child pornography offences.

For the same reason, it is currently not possible to separate trafficking offences 6. against children from offences against adults. All cases fall under the same provision under the Penal Code.

8. Female offenders: Total number of conviction decisions/Total number found guilty of criminal offences (source: Brå):

Child pornography

2009 – two decisions (one court conviction, one waiver of prosecution), of which one principal offence. Age of the women: 18-20 resp. 60- years.

2010 - one decision (court conviction, principal offence). Age of the woman: 60- years.

#### Question 1(b)

9. Apart from cases reported to the police, there are no statistics or estimations regarding the number of children being trafficked.

### Question 1(c)

10. There is no official statistical information available regarding the number of children given assistance for recovery and social reintegration. For further information see sections 45-52 of the previous Swedish answers sent to the Committee on August 15, 2011.

11. In 2010, 109 900 000 SEK was paid as state compensation to applicants (11 058 applications). In 2 101 cases, the victim was a child. 276 cases concerned sexual crimes against children. In 2009, 119 730 000 SEK was paid (11 058 applications). In 2 333 cases, the victim was a child. 265 cases concerned sexual crimes against children. In 2008, 113 584 000 SEK was paid (10 895 applications). Before 2009, the authority did not present the numbers of child victims. 271 cases concerned sexual crimes against children. ## Question 1(d)

12. The crime codes 0418 (trafficking in human beings for sexual purposes against children) and 0420 (trafficking in human beings for other than sexual purposes against children) were introduced in December 2008. The figures for 2008-2010 are therefore not comparable. "Prosecution rate" below includes cases where prosecutor fines or waivers of prosecution have been issued and prosecution. The crime code 1607 stands for child pornography.
