² In the case of CESCROPT - Article 10, the State has the option of making a declaration that it recognizes the competence of the Committee to receive and consider communications to the effect that a State Party claims that another State Party is not fulfilling its obligations under the Covenant.

³ In the case of CESCROPT - Article 11, the State has the option of making a declaration in accordance with Article 11. Under Article 11, a State may make a declaration recognizing the Competence of the Committee on Economic, Social and Cultural Rights

to examine information, or conduct confidential inquiries where the Committee has received reliable information indicating grave or systematic violations by a State party of any of the economic, social and cultural rights set forth in the CESC.R.

⁴ The Optional Protocol to the International Covenant on Economic, Social and Cultural Rights was opened for signature on 10 December 2008. The Optional Protocol will enter into force three months after the date of the deposit with the Secretary-General of the United Nations of the tenth instrument of ratification or accession.

⁶ Formerly Libyan Arab Jamahiriya. In August 2011, the Permanent Mission of Libya notified the Secretary-General of a Declaration by the National Transitional Council of 3 August changing the official name of the Libyan Arab Jamahiriya to "Libya" and changing Libya's national flag.

⁷ The Republic of South Sudan formally seceded from Sudan on 9 July 2011, as a result of an internally monitored referendum held in January 2011, and was admitted as a U.N. member state by the General Assembly on 14 July 2011.
