⁴ The former Yugoslavia had previously ratified CERD on 2 October 1967, CCPR on 2 June 1971, CESCROPT on 2 June 1971, CEDAW on 26 February 1982, CAT on 10 September 1991 and CRC on 3 January 1991. Subsequent to dissolution, the Government of Croatia deposited with the Secretary-General notifications of succession to these treaties, with effect from 8 October 1991, the date on which Croatia became an independent state.
